Training Segment

IIEST Federation has been active in conducting trainings since 2013 in order to achieve its objective, "To lessen the unskilled - labour gap existing in the industry by customizing manpower training programs." We have partnered with many Govt. of India agencies as well as various agencies of states governments in order to provide trainings to the manpower of India who has a lot of undiscovered and unpolished potential. This potential is needed to be carved out. Therefore, IIEST Federation has been conducting trainings in the following segments.-

- ➤ Capacity Building Trainings
- > Technical Skill Trainings
- > Entrepreneurship Development Trainings



Capacity Building Training Programs

Capacity Building Training Programs enables people, communities and organizations to strengthen their capabilities to develop implement and maintain effective services. Therefore, in order to develop the capabilities of the already existing workforce of India, IIEST Federation initiated the Capacity Building Training Programs and catered various government and non-government organisations.

1.1 PROJECT- FSSAI, GOVT. OF INDIA

SCHEME- Food Safety Training & Certification Program (FoSTaC)

Background-

Access to sufficient amounts of safe and nutritious food is the key to sustaining life and promoting good health. Unsafe food containing harmful bacteria, viruses, parasites or chemical substances causes more than 200 diseases, ranging from diarrhoea to cancers. It also creates a vicious cycle of disease and malnutrition, particularly affecting infants, young children, elderly and the sick. Good collaboration between governments, producers and consumers is needed to help ensure food safety and stronger food systems. Therefore, FSSAI, Govt. Of India launched the Food Safety Training & Certification Program with an idea of promoting the food safety and hygiene habits amongst the food venture owners and workers and also the customers. Taking the motto ahead, IIEST Federation collaborated with FSSAI and started giving trainings under the scheme in 2019.

Introduction-

FSSAI had initiated the largest Food Safety Training & Certification (FoSTaC) programme in July, 2017. The FoSTaC programme is implemented in order to provide the certificate to food venture owners after giving them the proper training regarding the food safety and food hygiene. Food Safety Supervisors (FSS) are trained in good hygiene and manufacturing practices as per requirements in Schedule 4 of Food Safety and Standards Licensing and Registration Regulations, 2011.

IIEST Federation has been in partnership with FSSAI since 2018 and has been implementing the scheme since then in Delhi, Assam and Himachal Pradesh.

Vision of the Government Scheme-

As per PM Narendra Modi's statement, "Safe, wholesome and hygienic food will create 'Swastha Bharat'. This has to be cornerstone of the efforts of FSSAI." Under the vision of 'Swastha Bharat', Government wants to implement the idea of providing safe and healthy food to each and every citizen of India.

Objectives of the Scheme-

- ♣ To enhance the availability of skilled/ trained manpower in the food industry.
- Creating an improved environment of self-compliance to FSS Act, Rules and Regulations by the responsible Food Businesses.
- Bringing a behavioural change and inculcating a culture of Food safety in the country.

Implementation by the Federation-

It is necessary to educate the food handlers regarding the food safety practices that they must be following in order to serve their customers. FoSTaC training has therefore been initiates by the Govt. of India. The Federation has been an implementing partner with the FoSTaC initiative, and it has implemented the scheme using the awareness method, thereafter, providing the training to the food handlers and later providing them with the certification as per the law, under "Part 1 of Schedule 4" of Food Safety and Standards Regulations, 2011, under Food Safety and Standards Act, 2006. A team of mobilisers, by stepping on the field in Delhi NCR region, contacts the FBOs and educate the food handlers regarding the food safety practices. They are told about why the Training and certification is compulsory for the FBOs and the handlers in the business. The food handlers are then enrolled for a 2-3 hours food safety training and assessment about the same, where, they are given the demonstration and trainings regarding the practices that they must be following at their hotels, and restaurants. There is a set syllabus for the same, which includes, chapters such as-

1. Introduction to the Food Safety

Under this part, they are educated about the basic safety practices and food safety hazards, food spoilage, etc.

2. Location, Layout & facilities

In this particular part, the food handlers are taught regarding the location and the surroundings that their business should be located in and also the Layout and the design of the food establishment premises.

Also, the type of equipment and containers that should be used by them throughout the process.

3. Food Production

The entire process starting from the raw materials to the serving of the food on the plate of the customers and the practices that need to be followed, are explained in this particular part. Receiving of the Raw materials from the market, their storage, pre preparation practices, cooking of the dishes, storing, distribution, serving practices and etiquettes, waste disposal, all are a part of this section of the training.

4. Personal hygiene

This is one of the most important practice that needs to be followed by those who prepare as well as serve the food. Personal hygiene including washing of hands, trimming of nails, proper haircut, wearing clean clothes, etc. are included in this part.

5. Pest Control

Where there is food, the danger of the pests spoiling them is something inevitable; therefore, it is very important to keep a check on the pests including mosquitoes, flies, and rodents because they will not only spoil the stored food, but also will be responsible for causing many diseases.

The food handlers, thereafter have to go through an assessment and then are provided with a certificate. They are also provided with the videos about the trainings so that they can revise further. The Federation has outreached a total of 1000 candidates, where, 900 candidates were trained. The Federation has been to be able to accompany the Govt. of India in providing safety training to the food vendors, retailers, restaurant owners and workers and helping them in creating a better environment for healthier Nation.

Thereafter, all 900 people became the certified beneficiaries under the scheme. Although there has been a scope for improvement that we are looking forward to achieve in the coming time.



Entrepreneurship Development Training Programs

2.1 PROJECT- NATIONAL PRODUCTIVITY COUNCIL

SCHEME- ENTERPRENEURSHIP DEVELOPMENT PROGRAMME (EDP)

INTRODUCTION:

The Entrepreneurship Development Program is designed to motivate, inspire, confidence and build capacity for establishment of an enterprise, manage and sustain the unit successfully by beneficiary. As per operational guideline approved by Ministry of Micro, Small & Medium Enterprises, Govt. of India PMEGP beneficiary has to undergo two weeks (10 Days) & six days (the project cost up to Rs 5 lakhs) Entrepreneurship Development Programme (EDP) before release of sanctioned loan to beneficiaries.

OBJECTIVES:

- * To impart knowledge on the concept of entrepreneurship, its challenges and prospects.
- * To develop entrepreneurial on the concept of entrepreneurship, its motivation, risk taking ability, confidence, and goal setting ability of the potential entrepreneurs.
- * Impart knowledge on procedure and formalities of setting of an enterprise /business.
- * Develop skills on management of a unit/business establishment including financial and marketing.
 - * To impart knowledge on identification of business opportunities and preparation of business plan.

IMPLEMENTATION BY THE FEDERATION-


IIEST Federation has partnered with the National Productivity Council in order to implement the EDP Scheme. The Federation in the year 2021-2022 signed MoUs with Kamala Nehru College and Indian Institute of Forest Management to implement the trainings amongst the Students of these institutions. With the Implementation of the scheme, the federation aimed to impart and enhance the entrepreneurial skills among the students, which will lead them to build their own startup and also they will be able to face and manage the challenges that could act as a barrier in their venture.

The beneficiaries in the Kamala Nehru College, received the training how to begin their own startup in the future. In the EDP training, focus was on the entrepreneurship skills and mindset in them, to fulfill the overall objective of the EDP that is to be able to set up their own enterprise, learn marketing, finance and management strategies and run their entrepreneurial ventures smoothly and successfully. The students who get graduate from the various Govt. and Private Institutions, will have the conceptual knowledge of their field but in order to develop the practical and entrepreneurship skills in them is the need of the hour as the vision of the Govt. of India is to Impart the Skills into the Youth of the nation to make them able to help them in the Nation Building process.

The beneficiaries from the Indian Institute of Forest Management were given the trainings under the set syllabus, where they were taught the skills regarding the management of the Forest and the Agriculture and the resources provided by them. This was under the convergence of the National

Productivity Council, and the beneficiaries were given the Government certification, so that they could further have a clear motivation and a path to become entrepreneurs in the particular field, or to be able to get employed with an organisation working towards the forest management. On a larger level, they could be able to help the various State Governments and the Govt. of India in the management of the green cover of India, leading towards a better environment.

OUTCOME ANALYSIS-



In 2021-2022, the Federation, in collaboration with National Productivity council, Govt. of India initiated the program for the Indian Institute of Forest Management and Kamala Nehru College, University of Delhi. The Federation, successfully provided benefits to the college students, who later on were confident enough to plan about becoming the Entrepreneurs in the future. The beneficiaries of the project, from the

Indian Institute of Forest Management were elated to receive the benefits and the Govt. Certification, which would help them further. The beneficiaries of the scheme could therefore become successful entrepreneurs not only to sustain their own livelihood, but also to become job givers for those who are in the need of employment, therefore help India in becoming self-reliant as envisaged by the Govt. of India.

2.2 PROJECT- NSDC, GOVT. OF INDIA

SCHEME- ENTERPRISE ADAPTABILITY PROGRAM (EAP)

Introduction-

IIEST Federation, true to one of its objectives, is committed to support & promote livelihoods programs through its Incubation vertical. In this regards IIEST has developed a project which aims at sustainable self-employment under NSQF alignment. This program "Enterprise Adaptability Program" provides safety net to start-ups & self-help groups successfully adapt to the market need and thus sustain the business. A Scheme under the aegis of Federation certified by India Skill, Assessment Agency of DGT, Govt. of India, it helps the start-ups to arrange funds and get leverage with financial institutions. IIEST Federation, under the assessment guidelines of India Skill, DGT, Govt. of India. Agency responsible to assess the training programs under Ministry of Skill Development and Entrepreneurship, Govt. of India.

Objective of Program-

Accelerate the skill development process, learning ability, competency building and application-based learning – essential for any entrepreneur / professional / individual to stay ahead of the competition in a dynamic and fast changing global environment.

Implementation by the Federation-


National Skill Development Corporation (NSDC) has been set up with the vision of development of the skills that the population of India holds. The Indian youth, undoubtedly has a lot of potential and can become great entrepreneurs if provided with the right platform. Therefore, IIEST Federation, under the guidance of NSDC, has launched the Entrepreneurship Development Program (EAP) in 2020 and it has been implementing the program since then by providing central institutions to various Private training institutes..

Blue Ribbon QMS Solutions was one of recipients of the program. The trainings and certification were given by the Federation, to the candidates for the job role of Aviation Internal Auditor in the Aviation Sector. This was the job role training under the training and assessment section of NSDC, MEPSC. IIEST Federation conducted the trainings for five days and educated the beneficiaries regarding the role and also imparted the technical skills among them about the role. The training was given under a specified schedule, where, lessons on The essentials of the Internal Audit, the practice and the business knowledge of the Internal Audit was given to the beneficiaries. Blue Ribbon QMS Solutions is a private entity that wanted to give the training under the affiliation of the IIEST Federation. In order to enhance the skills of the beneficiaries, proper trainings are necessary to be given to them for the role of Aviation Internal Auditor. Also, with these skill trainings, they would be able to upgrade their technical skills in the job role and therefore would be able to get the certification by the Govt. of India. They would therefore be market ready to get employed for the role in the Aviation sector. The Federation outreached a total of 15 candidates and 11 were trained and certified under the program, which could later on become the masters in their fields, having proper skills and earn a livelihood for their family, and also impart those skills to the youth, who would be able to use them further for the overall development of India.

Outcome Analysis-



The IIEST Federation has been quite active in providing trainings, successfully. Due to this reason, The Federation has been able to receive various central affiliations. The training was aligned with NSQF level 6, which provides safety net to start-ups & self-help groups successfully adapt to the market need and thus sustain the business, because is an absolute necessity in today's world, where more and more

startups are being initiated. The Training and certification for the Job role of Aviation internal Auditor provides the beneficiaries the knowledge about, The audit requirements, procedures, and skills they need to know to get started as an internal auditor. This course prepared them to conduct consistent audits and drive continuous improvement within the organization. Learn about the audit process through a breakdown of its stages: the audit scope, objectives, follow-up and closing; and practice using techniques that deliver objective, measurable results. International audit requirements are covered in detail followed by a hands-on practical component. EAP trainings will not only promote the livelihoods of the people connected with the venture, but also on a larger level, promote the vision of the Govt. of India regarding startup India, by creating a sustainable business environment.

IIEST Federation has been able to do so by providing trainings to the candidates, where under EAP scheme, out of the 15 candidates those were outreaches, 11 availed the benefits and the NSDC certification.



Technical Skill Training Programs

3.1 PROJECT- Management & Entrepreneurship and Professional Skills Council (MEPSC)

SCHEME- CERTIFICATE COURSE IN GIS MAPPING AND DATA ANALYSIS

Geographic Information System (GIS)

Introduction of UGC-NSQF Scheme-

Government of India, taking note of the requirement for skill development among students, launched National Vocational Education Qualification Framework (NVEQF) which was later on assimilated into National Skills Qualifications Framework (NSQF). Various Sector Skill Councils (SSCs) are developing Qualification Packs (QPs), National Occupational Standards (NOSs) and assessment mechanisms in their respective domains, in alignment with the needs of the industry. UGC implemented the scheme of Community Colleges from 2013-14 in pilot mode on the initiative of the MHRD.

National Skills Qualifications Framework:

The National Skills Qualifications Framework (NSQF) is a competency-based framework that organizes qualifications according to a series of knowledge, skills and aptitude. The NSQF levels, graded from one to ten, are defined in terms of learning outcomes which the learner must possess regardless of whether they are obtained through formal, non-formal or informal learning.

Job Role: SURVEY SUPERVISOR (GIS).

In GIS program below given topic were taught to gain skills necessary for sustaining a job in the company as survey supervisor. GIS course duration was 280 Hours (6 Months) this course seats.

Assessment done- MESPC -NSDC, Govt. of India

Implementation by the Federation-

IIEST Federation is an industrial training partner of NSDC-MEPSC and was responsible in coordinating and implements the project along with KNC as per the guidelines under UGC-NSQF scheme. The Federation signed an MoU with Kamala Nehru College, University of Delhi, where those students who were interested, were given the technical training of the job role of Survey Supervisor (GIS), with the practical knowledge of the job role, aligned as per the NSQF. The Federation outreached a total of 9 candidates, where all of them were given the desired benefits of the trainings.



Under The National Qualification Skill Framework, The technical trainings provided are to the beneficiaries, based on the job role that they wish to get trained in, and to make them technically skilled for the job role that will be valid both at the national as well as international level. **IIEST** Federation successfully implemented the project- Management

& Entrepreneurship and Professional Skills Council (MEPSC) and provided the training under the job role Survey Supervisor (GIS), to 9 beneficiaries and made them eligible to get employed under the job, not only sustaining their own livelihood, but also contributing towards the economy of the Country, by making them able to do the Geographical survey of the land which would be leading to the geographical development of India.

Introduction-

In 2019, IIEST Incubation and Business Centre was launched with an idea of Work Optimization Through Space To Achieve Productive Ambience For Business. 200+ clients received our services, where they used office space provided by us and were successfully running their start-ups. The motive behind starting the co- working space was the start-up India initiative launched by the Government of India.

4.1 PROJECT- DPIIT, GOVT. OF INDIA

SCHEME- START-UP INDIA

Start-up India is a flagship initiative of the Government of India, intended to catalyse Start-up culture and build a strong and inclusive ecosystem for innovation and entrepreneurship in India.

Launched on 16th January, 2016, the Start-up India Initiative has rolled out several programs with the objective of supporting entrepreneurs, building a robust Start-up ecosystem and transforming India into a country of job creators instead of job seekers. These programs are managed by a dedicated Start-up India Team, which reports to the Department for Industrial Policy and Promotion (DPIIT).

Having this idea in mind, IIEST Federation wanted to expand itself in the area of incubation and business and wanted to provide more resources to those who were new in the entrepreneurship sector and wanted to grow further. Thereafter, we decided to launch IIEST incubation and business centre.

Vision of the Government Project-

Startup India is the flagship initiative of the government, launched in January 2016, which intends to build a strong ecosystem for the growth of Startups, to drive sustainable economic growth and generate employment opportunities. The Startup India action plan provides tax and other incentives.

Objectives of the Project-


- The objective of the Startup India Scheme is to build a strong ecosystem for promoting innovation and startups in the country.
- Further, such a drive would encourage sustainable economic growth and create large scale employment opportunities.
- And to reduce the regulatory burden on Startups, thereby allowing them to focus on their core business and keep compliance costs low.

IIEST Incubation & Business Centre-

IIEST Incubation and Business centre is a concept which provides a platform for a business to achieve maximum output. Idea was imbibed in the "Wheel of Incubation", which reflects the model of providing all services at a single platform for a start-up. The highly successful initiative of the Govt. of India, is the Startup India Mission which tends to ensure an ease to those who wish to begin their own enterprise or a startup. India being immensely rich in natural and human recourse, has a lot of potential of becoming the world leader in the coming years, and in order to overcome this idea, It is necessary for its population, easpecially the youth, to become self-reliant and independent. Therefore, there is a need to provide them the resources that they would need in order to run their venture without any restrictions in the future. To ensure the idea to facilitate business operation solutions, for Start-ups and SMEs (small medium enterprises) or free-lancers, in a cost-effective yet quality driven services, Start Coworks come into existence as one end solution of the incubation wheel.

Start Coworks, which means Start-up and Co- working Space is an idea that came under the concept of Business Incubation. Those supporting the start-up or new companies are called business incubators. These business incubators see the growth potential and weigh the opportunity before supporting or funneling funds into any start-up. With this idea in mind, the Federation established Start-Coworks which is benefitting a large number of beneficiaries.

Outcome of the Project-



IIEST Federation has been able to provide the support under the startup India mission to 61 Startups during 2021-2022. We have been able to provide help to them by giving them office space at subsides cost which helped them to begin their startup, without worry about costly office space. Those who

required the virtual space, were provided that, with the services such as Recruitment services, IT services, fundings, legal services, GST related services, digital marketing, promotions, and other necessary resources were provided by the Federation to them, under the tutelage of Start up India Mission.

The second wave of the COVID-19 pandemic struck India and severe restriction were placed during this time. The businesses were shut, new businesses got completely destroyed. Due to these reasons as well there prevailed a certain level of fear amongst the new startups. But, the young talent of our country, when works towards upliftment of the nation, they help India to develop faster. Keeping this in mind, IIEST Federation has therefore, under the start up India Mission, planned to come up with this initiative. The Federation provided Virtual spaces to 52 statups and 9 people took cabin spaces from us.

5.1 PROJECT- FSSAI, GOVT. OF INDIA

SCHEME- FOOD SAFETY COMPLIANCE SYSTEM (FoSCoS)

Background-

Food Safety Compliance System (FoSCoS) is an enhanced version of Food Licensing and Registration System (FLRS) which was launched in 2012 for issuance of pan-India FSSAI Licenses and Registration. It had evolved incrementally and organically with changing regulatory needs. The technology on which it was built was outdated with technical support no longer available. Over years users complained of slow speed of FLRS and software experts resisted new changes on FLRS thus impeding any further improvement, expansion and innovation in the licensing system. Thus the migration from FLRS to FoSCoS was imperative.

Introduction about FoSCoS-

FoSCoS is built using latest technology with a vision to have modern on stop pan-India IT platform for food safety regulatory needs. FoSCoS is conceptualized as the umbrella system which is integrated with FSSAI's other existing IT platforms such as Food Safety Compliance through Regular Inspection and Sampling (FoSCoRIS), Food Safety Connect-Complaints Management System, Online Annual Return platform, Food Import Clearing System (FICS), Indian Food Laboratory Network (InFoLNet), Audit Management System (AMS), adjudications and penalties, Food Safety Training and Certification (FoSTaC), Food Safety Mitra (FSM) etc. These integrations will be done one by one in future until FoSCoS evolves from a licensing platform to a unified compliance platform. FoSCoS has a robust architecture capable of future extensions and enhancements.

FoSCoS shall also be integrated with other platforms of Government of India such as GST, PAN, MCA etc. further ease out the processes for businesses and also ensure a 360 degree profiling of businesses.


Implementation by the Federation-

The importance of FSSAI (Food Safety and Standards Authority of India) is that it is a body which is registered under the Food Safety and Standards Act, 2006. The role of the FSSAI is it registers the Food Business Operators in India. The FSSAI registration through FoSCoS (Food Safety Compliance System) is done in India for the manufacturing, processing, storage, distribution, and sale of food products.

The FoSCoS is an online medium by the government of India; it is provided under FSSAI registration of FoSCoS of FBO (Food Business Operators) in India. It works to provide the compliance services such as registration, licensing, document filing. It is the online medium.

IIEST Federation has partnered with FSSAI in order to implement the FoSCoS. In Financial year 2021-2022, we were able to register for 81 licenses, out of which, 79 were successfully provided and 2 were unsuccessful due to certain reasons.

Outcome Analysis-



Food and food products directly impact the health of the people and the welfare of the nation. The quality of food should therefore be strictly monitored. The food outlets should maintain adequate standards in order to be eligible to procure the FSSAI license.

The Federation was able to mobilise and educate 79 food handlers. And also provided them with the

mandatory licenses in order to make them eligible to run their food business successfully.

The Food Standards and Safety Authority of India (FSSAI) is the authority that is accountable for regulating and governing food safety in India. The FBOs within India must obtain a license under FSSAI mandatorily. The license can be applied for and renewed online through the FSSAI portal. The license is therefore indispensable for the functioning of the food businesses in India and obtaining it bestows a number of advantages for these establishments.

Obtaining a license can provide the food business with legal benefits, build goodwill, ensure food safety, create consumer awareness, and assist in business expansion. Also, it helps regulate, manufacture, storage, distribution and sale of import food. It is easy to obtain funds from investors when an FBO has FSSAI registration.

Introduction-

In 2021-2022, a Market Research titled "A Need Assessment Survey of Food Processing & Healthcare Sector to Measure the Status of Readiness for Adopting Industry 4.0 Technologies in MSME in India" was published by the Federation, in partnership with the Nitcon Ltd. and was submitted to the National Productivity Council of India.

Relevance of the Study-

With growing discussion on sustainable development and growth based on profitability, social and environmental aspects, the industries are moving through transition phase which demands a lot of change and restructuring of work and processes within the manufacturing industry. With introduction of Industry 4.0 parameter the industries are expected to develop, redesign and remodel their system in a defined and guided manner so that there is an equilibrium across the industries and sectors. Present study is an effort to presents the real and practical picture of the manufacturing systems related to two sectors i.e. Food processing and Health care manufacturing industries, so that the focused and meaningful strategies can be drawn for the uplifting the industrial performance level and also the efforts can generate countable results at both qualitative and quantitative front. The study can also guide for a meaningful direction towards the similar effort to be made for the development of other type of industries and several other sectors.

Purpose of the Study-

The aim of this study is on devising an integrated framework of adoption readiness assessment of Industry 4.0, in the context of MSMEs, specifically in the food processing & healthcare sector. It will enable one to evaluate the extent and status of readiness among firms for adopting Industry 4.0 technologies. Therefore, the project is assessing the extent to which Industry 4.0 has been implemented across the various functional divisions in the organizational perspective. It incorporates the ways human- technology interface can lead to the successful adoption and implementation of industry 4.0 across firms in these sectors leading to sustainable developments.

Sample Size and Population: The survey of 100 SMEs was aim to cover the all-important Food Manufacturing & Processing MSME clusters of India, namely, Delhi-National Capital Region (NCR), Gurgaon-Noida region as well as Solan-Chandigarh region.

Conclusion-

➤ It was concluded through the analysis of the study that the adoption of the Industry 4.0 readiness in Healthcare sector is fairly implemented on the dimensions referred in Bharat 4.0 i.e. System, Organisation & Strategy - Leadership, Support, System, HR and Process, IT System, Connectivity, Process and HR of Industry 4.0. The findings also indicate that the adoption of Industry 4.0 is relatively less for Business Model and Product in this sector,

- whereas product adoption is inadequate, so these firms must evolve a business model considering the perspective of all the stakeholders.
- ➤ In Food-processing sector, the overall adoption of Industry 4.0 is relatively less in comparison to the health care sector at every dimension. More specifically, it is observed that the firms in this sector need to strategize the Organisation & Strategy through Leadership facilitation, Support, and HR Process mechanisms and System in massive manner to remain worthwhile.
- This is also interpreted in the findings of this survey which emphasizes that Leadership is the most important predictor of adoption of Industry 4.0 with its outcome in both the sectors. So, firms in both the sectors need to focus on aspects related to Leadership, Support, System, HR and Process. In both instances, Leadership is necessary for the organizational readiness with a focus on integration with suppliers & customers in its Support, System, and Processes leading to effective digitalization and Industry 4.0.
- ➤ When comparing the two industries i.e. Food Processing and Health Care Manufacturing on the basis of their Readiness Adoption of Bharat 4.0, the Health Care sector looks progressive comparatively but still there is a long way to go. There is no company which stands on Top-Notch Level. 30
- Overall through the study, it is observed that all the functional activities i.e. from products to process to systems and organization level digitalization can be implemented successfully only if the employees are skilled and trained to accept and adopt it. So, capacity building is the most important aspect in technological adoption and successful implementation in both the sectors.

Memorandum of Understanding (MoU)

The Indian youth has the largest population in the whole world and their collective dream is to make India self- reliant and therefore drive its growth and help it in becoming a developed nation. In order to achieve this dream, it is important that the young work force of the country is skilled enough and is able to contribute towards the GDP of the nation.
